- Police Chief Cory Smith reported on police activity for October 2025 (see attached document) and briefly explained the features of the newly operational Axom body cameras.
- Mayor David Cates discussed introducing an ordinance for electric scooters, referring to Montana Law, and Police Chief Cory Smith explained the current police procedure on citing offenders.
